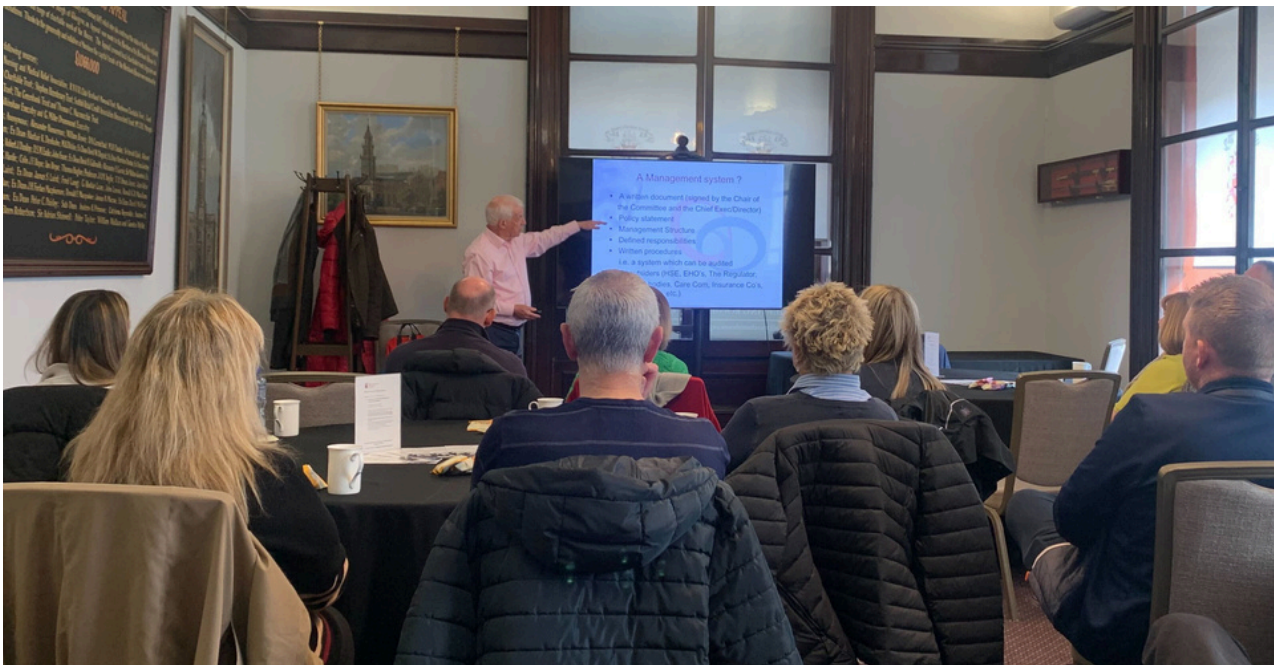

# CONTAMINATED LAND

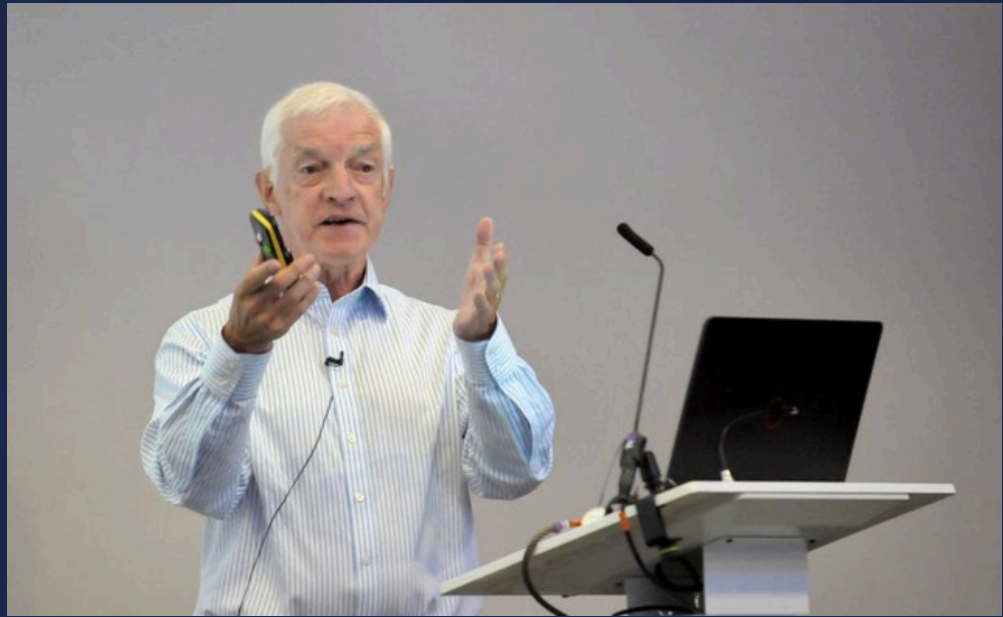
